Summary:

Essential Duties Include, but are Not Limited To:

- Uphold the highest quality cleaning standards
- Show attention to detail in cleaning of hotel rooms and public areas as directed
- Display effective time management in the performance of duties
- Utilize room inspection program with checklists
- Show ability to work independently when called upon to do so
- Take care of guests' needs in a timely and efficient manner
- Maintain a clean, organized work environment at all times, including housekeeping carts
- Other duties as assigned by manager

Qualifications

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. Education and/or Experience:
