The Memorial Garden at Chautauqua Park, LLC Conditions for Placement of Ashes

1. Ashes for placement in The Memorial Garden at Chautauqua Park will be placed without a container in a manner that in the course of time, they will be returned to a natural earthly condition in keeping with the scriptural reminder of "Ashes to Ashes, Dust to Dust."
2. Ashes for placement may otherwise be placed in a biodegradable linen bag or biodegradable container. No ashes will be exhumed or removed.
3. Payment will be used exclusively for operation and improvement of The Memorial Garden at Chautauqua Park. No property right of any kind is acquired by or through participation in this agreement.
4. A permanent record of the placements will be maintained by the Lakeside Association. The family may select an optional inscribed marker, determined by The Memorial Garden at Chautauqua Park, for an additional fee.
5. Flowers and other memorial decorations, other than those supplied by Lakeside Chautauqua are not permitted at any time.
6. Arrangements for placement shall be made with the Lakeside Chautauqua Religious Life Department.
